

Cookies Policy

The privacy and security of customer information provided by users through the website is one of HiSky's priorities. The following information helps users to understand what information HiSky collects via its website and how this information is used. The HiSky website uses cookies to provide users with maximum convenience. Visiting and using the HiSky website, the user acknowledges, without any limitations and reservations, that he has read, understood and agrees with the terms and conditions of this Policy and accordingly agrees to the cookies use in accordance with the Policy.

What is a Cookie file?

A Cookie file is a small text file located on the user's device and designed to provide ease of use of the site and save time. The cookies collected by HiSky do not contain information that can serve to identify individuals.

Cookies can be permanent or session.

Permanent cookies are saved by the browser and remain valid until the expiration of the retention terms:

- i. at the end of the session (for example, when the browser is closed);
- ii. the expiration date was specified, and the storage period expired;
- iii. the browser has deleted the Cookie upon the user's request.

Session cookies become invalid after the expiration of their validity. HiSky uses both session and permanent cookies on the <https://www.hisky.md> website and all its subdomains.

Assignment of cookies and tags used by HiSky:

(a) Functional "Cookie" Files

Anonymous cookies that allow users to navigate the HiSky website, use its functions and access the protected sections. They also facilitate the site navigation and are used for the following purposes:

- i. reminder of the selected country and provision of up-to-date content;
- ii. remembering the departure airport when booking a flight;
- iii. ensuring proper operation of the website.

The information collected by these cookies is not intended for marketing purposes. If this type of cookie is disabled by the user, some sections of the HiSky website will not be available for the user.

(b) Targeting, Marketing, Third party "COOKIE" Files

These cookies serve to send different versions of the web page for marketing purposes, and are used for the following purposes:

- i. display of relevant and personalized advertising;
- ii. limitation of the number of displays of each type of advertising;
- iii. determination of the effectiveness of the advertising campaign;
- iv. remembering visited website pages, tickets bookings, tickets searches and providing the collected data to third parties, for example, advertisers. These cookies are often linked to the functions of the website provided by the relevant third party.

Cookies do not pose any threat to your device, since they are just text files, not executable programs. You can either configure your browser to receive our cookies, or use the HiSky website without these features. In the latter case, the text data that you enter into the forms cannot be saved for the future searches, and the next time you visit the HiSky website, you will have to enter the information again. At the same time, unfortunately, HiSky will also not have the opportunity to prepare and offer you the convenient content.
